Note: The proposed increase in Annual Subscriptions

The accounts to March 31st, 1983 show a net deficit of £14,315 on the year. After crediting other receipts at £21,508, mainly investment income, and providing for special expenditure there is a balance of £5,129 to transfer to the Capital and Margary Fund which will then stand at £261,647.

Members' subscriptions of £6,067 did not even cover the £9,569 expenditure on publications and were even less adequate to provide for the total expenditure of £21,681 incurred in running the Society. The members are not therefore paying for the cost of the services with which they are provided, and would not receive these services at their present subscription costs but for the income derived from the munificent bequest of the late Mr I. D. Margary.

At a Special General Meeting held on December 2nd, 1978, subscriptions were

increased, with effect January 1st, 1979 to the rates set out below:

In the intervening period the movement in the retail price index has been:

An increase in the Ordinary Member's subscription from £6 to £10 p.a. (66.7%) would therefore do no more than to compensate for the inflation in costs since September 1978 and would provide no cushion against the inflation which is almost bound to occur (but hopefully at a lower rate) over the next five or so years before action will probably be taken again to review subscriptions. A postponement of the decision to increase subscriptions now would necessitate a greater percentage increase if sought later which Council considered would be undesirable.

It is therefore proposed that a Special General Meeting be convened to precede the next Annual General Meeting. The proposed subscriptions are given above, and the Ordinary Member subscription of £10 will cover that of any Junior Member (without Collections) at the same address. If this Special Resolution is passed, it is intended that a part of the additional revenue will be applied in increasing the frequency of the issues of the Bulletin.

Accommodation for the Society

Several members have enquired the present position of the Society's long search for larger and more convenient premises, and it may be useful to set down briefly the sequence of events.

Various schemes have been considered by Guildford Corporation, over at least 20 years, for the enlargement of Castle Arch, or for inclusion of the Society in new

municipal or county offices, but none of these has materialised.

Meanwhile, the Society's officers, and for a time a special Premises Committee, have investigated a number of buildings which came on the market. These included a site in Quarry Street; a house close to Castle Arch; a house with lecture hall in Farnham Road; an old people's hostel at Witley; two or three redundant schools; parts of a mill at Guildford, of Catteshall Mill, and of the Farnham Maltings; and several others in the county of greater or lesser potentiality. Much effort and activity, and some expenditure on architects' appraisals, was put into these leads.

It became apparent that a common thread ran through all these enquiries — even if planning consent could have been secured for what in some cases was a change of use, the initial cost of the building would in every case have needed to be increased by the cost of renovation, alteration and equipment, and to this would need to be added the running costs (which would have entailed the employment of staff), which could

not be afforded out of the greatly reduced income of the Society.

As a result of this long and disappointing search and its implications, it has emerged as the best policy, at least for the forseeable future, to rely for additional accommodation on the *ad hoc* hiring of rooms or premises in reasonable reach of Castle Arch.

As a corollary, the management of the Society's funds has been changed, over the last two or three years, from keeping a sum in reserve for use, at short notice, for the purchase, refurbishing and upkeep of separate premises, to skilful redeployment of holdings with the object of increasing the Society's capital in the long term, and also its income. Even with this change of financial policy the running expenses are now increasing at an uncomfortable rate, as the accounts which will be presented to the AGM in November will demonstrate.

NOTES AND QUERIES

Off Half Moon Street, Bagshot (SU911634)

The Sarsen Stone foundations of a building with a demolition layer of the 17th century, cut by 18th century brick constructed drain, has been recorded.

Nos. 48-54 High Street, Bagshot (SU912634)

Following a trial excavation at Christmas 1982, the site was further examined in April 1983 with the object of sampling peat deposits and the possible medieval street frontage.

The peat deposit, from which a late 16th century shoe had previously been recovered, had been interpreted as an area of waste or meadow land bordering a timber revetted ditch, overlain with a levelling layer of gravel in the 17th century to

create a "firm based" yard for ancillary building structures.

The excavation failed to locate any medieval structures although the earliest levels exposed were of the medieval period comprising trampled waste ground cut by a

boundary or drainage ditch.

In the 16th century a building had been constructed, partially cut into this medieval trampled layer, with external walls of tile creasing construction, subjected to one phase of alteration and finally demolished in the mid 17th century. The building had been used as a drinking house and this is evidence by material from the floor make-up levels comprising globular Rhine ware flagons (one bearing the date of 1599), fragments of glass bottles, fragments of bowls and approximately 30 complete stems of hollow cigar shaped and lion mask stems of wine glasses probably of the Mansell period.

Following mid 17th century demolition the site had been filled and levelled with gravel and a brick foundation timber-framed building erected. This was demolished in the late 18th century to make way for a brick building having three phases of

alteration, latterly known as the Red Lion Public House.

The co-operation and help from the site owners, Messrs Courage (Central) Ltd, is gratefully recorded.

Two Wal-names in Kingston Fields

Documentary research to locate Waleport and Walehull in Kingston will probably be

published in the Collections.

Briefly, Waleport (presumably meaning "land on, or site overlooking, the British Town") was immediately north of Coombe Road (about TQ196698 and TQ197698). Taddewell, near Burghditche, was about TQ202718. Walehull Furlong was east of the land near the present railway bridge over Lower Ham Road. A trial excavation was undertaken in the area in 1980 by the Kingston Heritage Unit (reported in Bulletin 174).

16 Bell Street, Reigate: Further Work (TQ255505)

Between April and June the Holmesdale Archaeological Group carried out a further excavation to the rear of the Georgian house in advance of restoration and a proposed shopping redevelopment (see Collections 74: 47-89) for final report on the

previous work).

To the east of the previous excavation a trench uncovered a further 5m or so of the building fronting Bell Street. Its medieval origin was proven and the suggested 16th century demolition date was confirmed by a penny of Henry VIII in the upper of three floor layers. Another medieval stone hearth and part of a possible partition wall were found. Brown loam containing 16th and 17th century pottery, a jeton, dog skeletons and horticultural pits overlay the building. Above this loam were scanty remains interpreted as the cobbled yard, soakaway and rear wall of a 17th century building fronting Bell Street. This house was demolished in the late 18th century and the area laid out as a garden.

Beneath the medieval house, as noted in the previous report, a layer of brown/grey sandy loam continued to the natural sand. Overlying the sand, at a depth of 1.7m, was an undisturbed spread of large sherds of coarse, sandy ware cooking pots. At one


point these were more concentrated and many sherds joined. A 20kg sample was taken from around this deposit and sieving is yielding carbonised seeds and the bones of fish and other small fauna. A barrel padlock was also found. A short distance from this sherd concentration and at a slightly higher level lay a French billon denier, a coin minted in Angouleme in the 12th century. Although its deposition date is uncertain the coin nevertheless provides supporting evidence for a C12th date both for the pottery in this deposit and also for the group of similar pottery from Pit 1 in the previous excavation for which a date of C.1200-1250 was proposed.

A trench was also dug in the rear garden in the hope of locating other pits. In the event this proved disappointing. A further section of the robber trench was

excavated however and a lead cloth seal was found elsewhere.

One find of local interest came from the main trench, from the layer overlying the medieval building — a glass bottle seal bearing the initials NRM surrounding a bell (see below). Jeremy Greenwood has almost certainly identified these initials as belonging to Robert and Mary Nicholson who are mentioned in a will of 1663 as being tenants of the Bell Inn. At that date the Bell was sited next door at No. 14 and the surviving timber-framed wing may well be part of that inn.

RECENT PUBLICATION

"Explore Guildford", a 20 page A5 booklet by Guildford Group of the Surrey Archaeological Society, is now on sale at Guildford Museum and local newsagents and bookshops (cost 60p). The booklet, illustrated by sketches and sketch maps, describes five short walks around historic Guildford based on completely revised walks described in their earlier "Discovering Guildford" leaflets. LIBRARY NEWS

The Library Committee at its last meeting agreed to continue the concession whereby the Society pays the outward charges on postal loans to members residing more than 20 miles from the library at Castle Arch. Charges incurred in returning these loans are still the responsibility of the borrower. Where only one article from a journal is required however, please give details of author, title and inclusive pages because, subject to copyright, a photocopy will be sent instead of the original.

It was also agreed to institute a Current Contents Service primarily for members who through distance find it difficult to keep up to date with the literature in journals. A copy of the contents pages of any journal currently received in the library will be sent to members requesting it and, subject to copyright, a photocopy of any article listed will also be supplied on request. For a trial period of one year this service is offered free of any charge to personal members residing more than 20 miles from Castle Arch, subject only to the limitation of six titles per year. Titles in excess of six will be charged at 10p a copy plus postage. Members within 20 miles of Castle Arch may also request the service but will have to meet all the costs. If you are interested in availing yourself of this service please contact the Librarian, Mrs Pat Ashworth, at Castle Arch, from whom a copy of the Short Title List of Journals currently received in the library can also be obtained.

Members are reminded that the Margary Room is open for the borrowing and return of books, and for study purposes, 9 a.m. to 5 p.m., Monday to Saturday. On Saturday afternoons and Bank Holidays application must be made to the Museum Steward for the key.
