C.B.A. GROUP 11A

It may be of interest to outline recent developments in the Council for British Archaeology which are likely to have considerable influence on the future of the Surrey Archaeological Society. A feature of the C.B.A. is the regional grouping, usually covering several counties, of county and local societies and museums for collaboration in matters of common concern. Group 11 covers Kent, Sussex and Surrey, but for various reasons has not been active.

During 1964 several ways of activating the Group, in the interests of local archaeology, have been considered. The solution finally adopted was to divide the Group into 11A, consisting of societies in Kent and Surrey, and 11B, those in Sussex. Since this decision was taken the Councils of the Kent and Surrey Archaeological Societies have agreed to go forward jointly in making the new Group 11A a success.

The first step will be a general meeting of the societies, museums etc., in Kent and Surrey who are either already members of the C.B.A. or are closely interested in its work. Arrangements for this meeting, which will be held at a centre convenient to most of the societies, are in hand and invitations will be sent out shortly. The object of this meeting will be to create a working machinery for the new Group, which can organise joint activities, foster relations with Sussex and with Group 10 across the Thames, and contribute to the annual report of the C.B.A.

A highly satisfactory feature of the negotiations of the past year have been the close relations, and the unamity on all essential issues, of the Kent and Surrey Archaeological Societies. This provides a sound basis for the future co-operation and for the efficient working of the new Group. There is every reason to believe that the local societies will share this attitude and play a full part in the activities of the Group.

EXCAVATION NOTICE

ORCHARD HILL, CARSHALTON: MESOLITHIC SITE (N.G.R.: TO 278643)

Directors: Mr. and Mrs. D. J. Turner and Mr. J. Giles.

The excavation of this important site, organised by the Beddington, Carshalton and Wallington Archaeological Society, is continuing at weekends. Building on the site is expected to start in the early summer and as much information and material as possible must be extracted from the site before it is built over. Volunteers are required both for digging and for the sorting of the mesolithic material. Offers of help with an analysis of the post mediaeval pottery (mainly 19th century) from the top soil would also be welcome.

Digging is carried out every weekend (weather permitting) and work starts on Saturdays at 10 a.m. and on Sundays at 2.0 p.m.

Access is from the track that runs westwards from the south end of Church Hill, Carshalton. The site is due south of The Greyhound P.H. and south-west of the parish church.

LOCAL NOTES

Byfleet: Grusmere (N.G.R.: TQ 068613)

Shortly to be demolished is Grasmere, Parvis Lane. The centre of the building is of eighteenth century date, but it had considerable additions about 1860 and later and is in very bad repair indeed.

Carshalton: Orchard Hill (N.G.R.: TQ 278643)

This site (mentioned briefly in the January Bulletin) is proving more important than had been expected. The density of flint artefacts indicates a working area but only slight undisturbed remains of a working floor have as yet been found. The material is mainly waste flakes, cores and calcined flint, but microliths and scrapers have also been found. A small quantity of R-B pottery and a few mediaeval sherds have been recovered as well.

Cheam: Whitehall (N.G.R.: TQ 243638)

Sutton and Cheam Borough Council recently acquired Whitehall at Cheam. This very fine, continuous-jetty type, Hall-house, with crown post roof of c. 1500, retains one original chimney with oven openings. A porch and staircase were added about the middle of the sixteenth century, when the attics and dormer windows were inserted and the large southern chimney added. A mid-seventeenth century addition to the rear is reputed to have been built in connection with Cheam School. The house was carefully restored just before 1800, when the weatherboarding was added. It is largely in this state, only minor additions of kitchen and w.c. being made at the back, and is a particularly fine example of its period. Plans and detail drawings have been prepared.

Nonsuch Cottage next door has a chalk block wall through the centre and, as originally built, about 1600, this was an outside wall. Two separate additions to the south were made in the late eighteenth or early nineteenth century, giving a square plan. The short row of cottages to the north were built about the same time as the first additions to Nonsuch Cottage.

Ewell: 31 High Street (N.G.R.: TQ 221624)

Barclay's Bank have applied for planning permission to rebuilt their premises at this address. Beneath the altered Georgian frontage is the frame of a sixteenth century timber house. C. S. Willis in *Ewell and Nonsuch* identifies it as the shop of Holland the draper, a Parish Constable in the eighteenth century.

Lambeth: St. Mary's Church (N.G.R.: TQ 306790)

In the *Transactions* of the Monumental Brass Society, Vol. X, part I, p. 36, a brass additional to those listed by Mill Stephenson (*Monumental Brasses in the British Isles*, 1926 reprinted 1964) is noted. The brass is in the nave of the church and bears the inscription: Georgiana, second daughter of Jonathan Tvers Barett. 1815. Act 3.

Worplesdon: Frosbury Farm (N.G.R.: SU 970522)

The barn at Frosbury Farm, recently reduced to a shell by fire is to be demolished. This is of queen strut construction and probably dates from the middle of the sixteenth century.
