#### Surrey Churches

The series of articles on the County's Churches, which have appeared for some years in the Society's Collections, has lapsed following the Subeditor, Mr. McDowell's departure to York. Mr. J. W. Lindus Forge, A.R.I.B.A., has now agreed to act as Sub-editor for the resumed series and will be glad to hear of any suitable material lying in manuscript which might form a basis for further articles.

#### Excavations at Gatton Bottom, Merstham (TQ 274536)

The S.A.S.'s rescue excavation of this site, due to be destroyed during the construction of the M25 motorway at Gatton Bottom, near Merstham, took place between 14th August and 28th August. The site was the find spot, near the turn of the century, of "Ancient British Coins", although records of the exact nature of the coins were destroyed during the last war.

A grid system of excavation was employed, though it was not possible to excavate the whole area of this large, leafy knoll, part of the Jubilee Plantations. The excavation was preceded by resistivity and fluxgate gradiometer surveys, both of which produced decidedly negative results. Finds included large quantities of roofing tile, glazed brick which was perhaps a product of the local lime kilns, and a scatter of pottery of

miscellaneous dates; there were no archaeological features.

Pottery includes an early Roman sherd, medieval and later sherds; two whetstones were virtually undatable in the absence of associated finds. A metal ring, made of bronze and bearing a linear design appears to be almost identical with a ring of the pagan Saxon period, from the Guildown cemetery. All finds will be deposited at the Guildford Museum, with a detailed report of the excavation. Finally, thanks are due to all those members who participated with such keen interest in the operations.

#### Dorking Relief Road

Numerous historic buildings in Dorking are threatened not so much by the proposed Relief Road, whatever its desirability, which it is proposed shall be driven through the town, but by the widening of by-roads and lanes into "feeder" roads to the new route. Many of the affected buildings are not of outstanding architectural or historic interest, and are therefore un-graded, but are nevertheless components in very attractive

townscape whose loss would rob Dorking of much of its surviving charm. It is for this reason that the Society's Conservation Committee is assisting the Opposition to the scheme who, by courtesy of the local authorities, are being allowed space to state their case at an exhibition early in November. We are preparing a plan which will clearly show all the surviving old buildings in the town, whether graded or not and the sites of those already lost. This should also underline the urgency of defining a "Conservation Area" for Dorking,

#### Kingston: Picton House

Despite its rich historical associations the borough is notably deficient in listed buildings of architectural or historic interest, and in recent years their number has steadily diminished; several have been demolished, while others are suffering a slower death from passive neglect. In the latter others are suffering a slower death from passive neglect. In the latter category is Picton House, an attractive 18th century building facing the river in High Street, Kingston. The building was acquired by Kingston Corporation in 1964 and has been vacant since 1967. This part of the High Street lies both in the Kingston Comprehensive Development Area and in Conservation Area No. 1—Kingston Old Town, In 1969 the Corporation decided to demolish Picton House which was then on the Supplementary List. Following representations by Surrey and Kingston Archaeological Societies the building was listed Grade II and in October 1970 Kingston Corporation decided to apply for listed building consent 1970 Kingston Corporation decided to apply for listed building consent to demolish the building. Societies and individuals made further represen-tations and a petition of some 1,500 signatures was collected. In February this year the Secretary of State for the Environment announced that a public inquiry on the demolition application would be held and this took place on 25/26th August. The intervening months gave time to prepare a detailed case for preservation. At the inquiry evidence was given for Kingston Corporation, the Greater London Council and objecting societies and individuals. The main objecting societies were the S.A.S. and the Kingston A.S., who were represented by Mr. Norman Nail. The River Thames Society was also represented, and individual objectors included Mr. Martin Morris, who acts as conservation secretary to the Kingston Archaeological Society. The Secretary of State's decision on the application has not yet been announced and is of course awaited with much interest. The joint representation of the two societies by Mr. Nail was an excellent example of a way in which a county and local archaeological society can co-operate, and one that perhaps could be developed in the future.

#### Kingston: Excavation at three sites

Three small excavations have been undertaken by Kingston A.S. in the last year. The first, directed by Mrs. M. Canham, was at Old Malden in the grounds of the Vicarage, Church Road (TQ 21256612), close to where in the late 1940s Mr. L. W. Carpenter discovered traces of Iron Age, Roman and Medieval occupation (S.A.C. L, 1946-47, pp. xxii, 152-6, and S.A.C. LI, 1949, p. xi). In the present excavation four trenches were opened immediately to the north of the old tennis court behind the Vicarage. A number of features, taking the form of silted pits or hollows and gullies were recognised cutting into the clay subsoil. Their fillings contained a small quantity of fragmentary Iron Age and Roman pottery and animal bone. A few sherds of green-glazed medieval pottery were found in the upper levels of the trenches. Further south two trenches were opened at right angles to the line of Mr. Carpenter's conjectured boundary of the Iron Age enclosure. Here the tail of a slight clay bank sealed an occupation deposit containing Iron Age and Roman pottery.

The second excavation, directed by Mr. S. Nelson, took place on the site of a row of demolished late 19th century cottages in Vicarage Road, Kingston (TQ 17816945). The site lies in the area of a proposed new road from Kingston Bridge and close to Old Bridge Street, the approach to the former wooden bridge across the Thames. A trench was opened parallel with Thames Street and the southern part was found to be much disturbed by service trenches of the Victorian cottages. Further north, however, an earlier period of brick building was sealed beneath the concrete base of the cottages. Two areas of brick paving associated with this earlier period sealed an occupation deposit which at present appears to contain nothing later than the late 17th century. This deposit overlies the Flood Plain gravels of the Thames. A brick-built well was also found beneath the concrete base and this is still being investigated. All periods from late medieval onwards are represented by pottery sherds, but most of the material, including clay pipes, dates from the late 17th century onwards.

The third excavation, directed by Mrs. R. Kenward, took place in the garden to the rear of 1 Thames Street, Kingston (TQ 17796921), in conjunction with the recording of this building.

Further details of the Kingston A.S.'s work will appear shortly. Wall foundations relating to the building were traced and perhaps date to c. 1600. Finds include late and post-medieval pottery.

#### Morden: Stane Street (TQ 252679)

Drainage works have been carried out during the summer months on the G.L.C. playing field in the north-east sector of Morden Park. During the cutting of the channels observations were made on the course of Stane Street. The channels were cut to an overall depth of 18in. on slightly sloping ground, and in general they sectioned the top soil and did not penetrate the London clay. Nothing was found to indicate the presence of a road.

This area of the park was part of the "paddock" enclosed by John Ewart in 1770. During the war (1939/45) and after it was cultivated as allotments and about 1952 was levelled and made into a playing field by the then L.C.C. It is possible that the Roman road was destroyed during levelling or may lie at a deeper level relatively undisturbed.

Observations were made during the early stages of the construction of the new Merton Technical College (TQ 250675) in 1970 and in 1971. Apart from what appeared to be the foundations of early farm buildings (Morden Park or Church Farm) nothing could be added to what had previously been found in 1959 (Turner, D. J., (1960), Lond. Nat., 39, 130-132).

#### East Clandon: A Possible Roman Dwelling Site (TQ 058524)

A coin found in a newly tilled field at East Clandon by a 13 year old schoolboy, Richard Kerr, has been identified as a sestertius dating from the time of Faustina (the wife of Marcus Aurelius, Emperor from 161 to 180 A.D.). This find has led to further discoveries.

In an area of about 100 square yards a large quantity of coarse pottery has been found. Types of pottery range from that used in the 2nd century to that of the 4th century. Pieces of three mortaria (one of Wiggonholt pottery) were found and also a number of flint balls which have been rubbed smooth.

Also found in the area were: fragments of roof tile, scraps of Samian ware, a few badly corroded metal objects, lumps of slag and furnace bottom, and a part of a quern stone.

The very great amount of pottery found seems to indicate more than casual occupation of the site, and the range of types and dates points to reasonable length of occupation.

The field where the finds were made is part of the Ryde Farm Estate, owned by Sir Charles Forte, and has recently been cultivated to a depth of 18 inches.
